Section 2: Hazards identification

2.1. Classification of the substance or mixture

Classification under CLP: Skin Corr. 1A: H314; Aquatic Acute 1: H400; -: EUH031

Most important adverse effects: Contact with acids liberates toxic gas. Causes severe skin burns and eye damage. Very toxic to aquatic life.

4.1. Description of first aid measures
